08 days Executive Development Programme (EDP) as applicable under earlier training structure is now available at the Institute's LMS portal at anywhere and anytime mode

Eligibility Criteria:

Applicable to all students registered in CS Executive Programme on or before 31.03.2014.

Important Instructions:

- 1. Only Executive programme pass students can register for e EDP.
- Student need to apply through stimulate portal https://stimulate.icsi.edu 2.
- 3. Stimulate Portal shall have validations according to the eligibility criteria. If any student is not eligible, then the portal will not allow them to apply.
- 4. Once the registration for e EDP(8 days) is approved on Stimulate, you will be given access to Elearning platform to pursue this program. If you are already present on e-learning platform, you may find e EDP(8 days) listed under "My Course" section on e-learning platform.
- 5. The login Id will be Registration number (without slash)@icsi.edu.For example, if the registration number is 123456789/02/2020 then student's Login Id would be 123456789022020@icsi.edu
- 6. Default password for first time login is Learn@1234. Existing users may continue to use their password.
- 7. Student log in id shall be valid for 30 days (from the date of approval)
- Student is required to complete all sessions (40 hours learning) within time period.
- 9. Fee for e EDP shall be Rs 750/- per student.
- 10. Student can undergo sessions at any time or any day with full flexibility of selecting the time.
- 11. Student can complete total learning of maximum 05 hours in a day. Once all the sessions of a particular day are completed, then the first session of next day will be available after a gap of 19 Hrs to 24 Hrs.
- 12. Till previous session is incomplete, student is not allowed to start any fresh session.
- 13. Total duration of all sessions of e-EDP would 40 hours
- 14. If any student is not able to complete the training within the time frame then the LMS access will be deactivated after 30 days and the fee submitted by the student will be forfeited. The student need to take fresh registration again in order to complete the requirement.
- 15. In order to get the completion certificate, it is mandatory to view the entire session with 100% attendance.
- 16. After successfully viewing all the sessions on the e-learning portal, students have to wait for 7 days to get the administrative approval for certificate generation. Till this time Course completion percentage will be around 97%.
- 17. Once the administrative approval is granted, Course completion percentage will become 100%.
- 18. Now students have to click on "Mark as Close" button on the portal and then "View Certificate" will become active through which completion certificate may be downloaded,
